SITUATION REPORT

INCIDENT NAME: Mile 3.0 Quartz Creek Road Used Oil Response **SITREP #:** 3 and Final

SPILL NUMBER: 11239918602

LEDGER CODE: 14314160

TIME/DATE OF SPILL: The spill was discovered and reported to ADEC on Wednesday July 6, 2011.

TIME/DATE OF SITUATION REPORT: 3:00 PM on August 10, 2011

TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: ADEC estimates that as much as 50 gallons of used oil was intentionally dumped into a fresh water pond.

LOCATION: Mile 3.0 Quartz Creek Road, Cooper Landing. Cooper Landing is on the Kenai Peninsula, approximately 100 road miles from Anchorage.

CAUSE OF SPILL: The spill appears to have been intentional. This case is being referred to the Department of Law, Environmental Crimes Unit.

POTENTIAL RESPONSIBLE PARTY (PRP): Unknown

RESPONSE ACTION: ADEC personnel responded on July 6, 2011, and began recovery efforts by deploying sorbent materials on the surface of the pond and secured the area with caution tape. On Friday, July 8, 2011, ADEC contracted Emerald Alaska Inc. to begin active recovery of the spilled product. Emerald started recovery with a crew of five responders and by Wednesday, July 13, 2011, the responders had recovered approximately 4 cubic yards of oiled sorbents and debris from the pond. Active recovery efforts were halted on the evening of Wednesday, July 13th. Sorbent material was left in place as a precaution. ADEC personnel have conducted periodic monitoring of the area and no additional oil on the surface or shoreline of the pond has been observed. The sorbent material that was left in place was removed by Emerald Alaska Inc. today and will be disposed of at a later date.

SOURCE CONTROL: The oil spilled from a 55-gallon drum, which was empty when it was discovered.

RESOURCES AFFECTED: The entire surface and shoreline of the one acre pond were impacted by the oil. No oil has been observed to have left the pond. The one acre pond was man made in the 1980's as part of a mining operation. No fish have been identified in the pond. The pond is used by a variety of waterfowl and mammals in the area. There have been no reports of oiled birds or mammals. Adjacent waterways of Crescent Creek and Quartz Creek have not been impacted by the oil. The Quartz and Crescent Creek are high recreational areas and are connected to the Kenai River Special Management Area.

FUTURE PLANS AND RECOMMENDATIONS: ADEC will leave a small amount of sorbent material at the outlet of the pond as a precaution and will continue to monitor the area for contamination. Alaska Department of Law, Environmental Crimes Unit and other law enforcement agencies will continue to investigate this release.

WEATHER: Temperatures in the mid 50's with periodic rain
