SITUATION REPORT

INCIDENT NAME: *Empress of the North* Grounding **SITREP #:** 6 and final

SPILL NUMBER: 07119913401 **LEDGER CODE:** 14233160

TIME/DATE OF SPILL: At approximately 12:35 AM on May 14, 2007, the vessel sent a radio report to the U.S. Coast Guard reporting the incident.

TIME/DATE OF SITUATION REPORT: 2:30 PM, May 23, 2007.

TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: A light sheen was observed in the immediate area of the grounding that may be due to the vessel. The vessel's crew reported there was approximately 25,000 gallons of diesel fuel oil on board the vessel at the time of the grounding. One empty fuel tank was breached during the grounding.

LOCATION: The vessel was originally reported to have grounded near Hanus Reef. Further investigation by the National Transportation Safety Board (NTSB) and the U.S. Coast Guard determined the vessel actually grounded on or near Rocky Island, a charted and marked reef, at the intersection of Icy Strait and Lynn Canal (Southeast Alaska) about 25 air miles southwest of Juneau. After the grounding, the vessel apparently drifted into the vicinity of Hanus Reef.

CAUSE OF SPILL: The vessel struck Rocky Island resulting in damage to the vessel's hull. The cause of the grounding is under investigation by the NTSB and the U.S. Coast Guard.

POTENTIAL RESPONSIBLE PARTY (PRP): Majestic America Cruise Line.

RESPONSE ACTION: *The Empress of the North* completed the transit to Ketchikan without incident arriving at Alaska Ship and Dry Dock, Inc. (Alaska Ship) on the morning of May 22, 2007. The vessel is currently moored at the facility prior to entering dry dock later today.

SOURCE CONTROL: Temporary repairs to the damaged areas of the vessel were completed and a portion of the potentially contaminated water in the damaged fuel tank was offloaded to a SEAPRO barge.

RESOURCES AFFECTED: Marine waters near Hanus Reef and Rocky Island. There have been no reports of impact to wildlife or other sensitive resources.

FUTURE PLANS AND RECOMMENDATIONS: Alaska Ship will begin preparing the dry dock for the *Empress of the North* at 4:30 pm May 23 and estimates the vessel will be in dry dock by approximately 9:30 this evening.

Repairs to the vessel are scheduled in two phases according to Alaska Ship personnel. The first phase will last approximately 9 days and then the vessel will be moved out of the dry dock so previously scheduled work can be conducted. The vessel will go back into dry dock on June 22nd for completion of repairs. It is not known how long the final repairs are expected to take.

The contaminated water currently stored in the SEAPRO barge will be treated in an oily water separator operated by Southeast Alaska Lighterage (SEAL), a local salvage company. The SEAPRO barge will be cleaned and both barges will be returned to service in Haines, Alaska where they are normally moored.

WEATHER: Current Ketchikan weather is Southeast winds at 8 kts, the visibility is ten miles under partly cloudy skies and the temperature is in the mid 50's.
